2025-26 Quality, Currency, Availability of Textbooks and Other Instructional Materials

Roseville City Elementary held a public hearing on September 25, 2025, and determined that each school within the district had sufficient and good quality textbooks, instructional materials, or science lab equipment pursuant to the settlement of Williams vs. the State of California. All students, including English learners, are given their own individual standards-aligned textbooks or instructional materials, or both, in core subjects for use in the classroom and to take home. Textbooks and supplementary materials are adopted according to a cycle developed by the California Department of Education, making the textbooks used in the school the most current available. Materials approved for use by the State are reviewed by all teachers and a recommendation is made to the School Board by a selection committee composed of teachers and administrators. All recommended materials are available for parent examination at the district office prior to adoption.

School Facility Conditions and Planned Improvements

General

The District takes great efforts to ensure that all schools are clean, safe, and functional. To assist in this effort, the District uses a facility survey instrument developed by the State of California Office of Public School Construction. The results of this survey are available at the Maintenance Office.

Maintenance and Repairs:

District maintenance staff ensures that the repairs necessary to keep the school in good repair and working order are completed in a timely manner. A work order process is used to ensure efficient service and that emergency repairs are given the highest priority. The District annually inspects wheelchair lifts, tests fire extinguishers, inspects and services all playground backboards, replaces bark on playgrounds and landscaping, and services HVAC units.

School Facility Conditions and Planned Improvements

The inspection included a check of possible gas leaks, mechanical systems, interior and exterior doors and windows, interior surface areas, structural damage, electrical, playground equipment, and hazardous materials. In all areas this school passed inspection.

Cleaning Process and Schedule:

The District has adopted cleaning standards for all schools in the District. The principal works daily with the custodial staff to develop cleaning schedules to ensure a clean and safe school.

Deferred Maintenance Budget:

The District participates in the State School Deferred Maintenance Program, which provides state matching funds on a dollar-for-dollar basis, to assist school districts with expenditures for major repairs or replacement of existing school building components. Typically, this includes roofing, plumbing, heating, air conditioning, electrical systems, interior or exterior painting, and floor systems. Since 2008-2009 the State has suspended the program due to State Budget Reductions. The District still maintains its own program.

2025-26 Opportunities for Parental Involvement

Stoneridge School actively engages families through various programs and events designed to strengthen school-home partnerships. The Parent Teacher Club (PTC) supports school-wide initiatives by funding programs such as Science and Art Docent and contributing to Positive Behavioral Interventions and Supports (PBIS) implementation. PTC maintains an informational website and holds monthly meetings where members discuss and vote on funding priorities and school improvement efforts.

The School Site Council meets regularly to review academic programs, school goals, and expenditures related to student achievement. Additionally, the English Learner Advisory Committee (ELAC) convenes to provide input on the development of the site plan for English learners, ensuring compliance with state and federal requirements.

To maintain open communication with families, Stoneridge uses multiple platforms, including social media updates and a weekly school blog. An annual parent feedback survey collects data to guide school improvement initiatives based on identified needs and trends.

Parents also have opportunities to participate in school events such as the World Fair, Jog-a-Thon, Picnic Day, Literacy Night, and STEAM Night. These events promote family engagement and build a supportive school community through collaboration and shared experiences. 2025-26 School Safety Plan

Stoneridge School is continually updating our school safety plan with input from our staff and the School Site Council. An annual school survey is used to gather data from all parents regarding facility and educational improvement needs. In addition, regular monitoring of the campus by the school site and the district safety committee ensures a safe campus. The Roseville City School District has developed a Crisis Response Plan that outlines the procedures to be followed in the event of an emergency affecting a school site. The plan includes procedures for coordinating resources to respond to any emergency including natural disasters, environmental health issues, accidents, or intruders. Staff have been assigned roles and trained to work efficiently with each other and with other public service officers to ensure the safety of students and staff. We conduct monthly drill practices on lockdown drills and fire drills to ensure that our students and staff are prepared in the event of an emergency. Fiscal Year 2024-25 Types of Services Funded

Stoneridge has strategically allocated funds to support four primary goals: improving student proficiency in English Language Arts (ELA), enhancing student proficiency in math, increasing proficiency for English Language Learners (ELLs), and strengthening attendance and overall school climate. To achieve these goals, the school has purchased new materials and manipulatives for math, reading, and Positive Behavioral Interventions and Supports (PBIS). Additionally, funds have been used to acquire supplemental academic curriculum designed to boost student proficiency and support academic intervention programs.

Investments have also been made in programs like Math Olympiads, IXL, Lexia, and instructional supplies that reinforce ELD strategies. To foster a positive school culture, resources have been directed toward implementing PBIS initiatives that promote a safe and supportive learning environment. Recognizing the importance of family involvement, Stoneridge continues to fund family engagement nights, creating meaningful opportunities for school-community collaboration. These efforts reflect a comprehensive approach to supporting both academic achievement and school climate.

Professional Development

Stoneridge Elementary aligns its professional development with the Roseville City School District's three-year plan. Staff participate in four districtwide professional development days that include both district and site-based sessions focused on advancing site goals within the district's overall priorities. Stoneridge professional development emphasizes essential standards in English Language Arts and mathematics, including strategies for progress monitoring and implementing small-group instruction within the math block. Staff also receive continuous training on Positive Behavioral Interventions and Supports (PBIS), focusing on Tier I and Tier II strategies, SWIS data entry, and behavior analysis to support student success. Additionally, Stoneridge is in the second year of implementing Restorative Practices, emphasizing relationship-building, repairing harm, classroom circles and fostering a supportive school culture.
